1 Introduction

Haskoning has a zero-tolerance approach to modern slavery, human trafficking and all other forms of forced labour and we are committed to acting ethically and with integrity in all our business dealings and relationships, implementing and enforcing effective anti-corruption systems, performing risk assessments and executing controls to ensure modern slavery is not taking place anywhere in our business or supply chains.

4 Implementing the Modern Slavery Act 2015

As part of our initiative to identify and mitigate risks Haskoning:

- Has published policies relating to the Modern Slavery Act 2015 and to Human Rights on our website (https://www.royalhaskoningdhv.com/en-qb/about-us/integrity).
- Has implemented training for Haskoning staff to ensure a high level of understanding of the risks of modern slavery and human trafficking in our business as appropriate.
- Created Integrity Moments as a mandatory topic on the agenda of all Haskoning staff meetings to raise further awareness and to enable our staff to share and discuss matters.
- Will provide all new employees with a copy of the <u>Code of Conduct</u>. During an induction programme new employees are made aware of the standards and values set out in the aforementioned policies.
- Has amended Haskoning's terms of business and standard sub-consultancy agreement to ensure our clients and suppliers maintain their own policies and procedures and are compliant with the Modern Slavery Act 2015.
- Has implemented annual internal audits to assess compliance with the Modern Slavery Act 2015.
- The Compliance Integrity Management System (CIMS) is externally audited by EuroCompliance. Our CIMS has been assessed and certified as meeting with the ISO37001 (anti-bribery management system) and ISO37301 (Compliance Integrity Management System).
- Has a whistle-blowing policy in place which protects the whistle-blower via a Speak Up Line, enabling people to report any matters or issues regarding any unethical behaviour. This can be reported via several reporting channels and the whistle-blower will be protected.
- Has a non-retaliation policy in place which protects whistle-blowers from any negative consequences.

5 Further Steps

As part of our ongoing compliance effort, we will continue to monitor, assess, and further implement steps to ensure that there is no modern slavery or human trafficking in our business.

This statement is made pursuant to section 54(1) of the Modern Slavery Act 2015 and constitutes our modern slavery and human trafficking statement for the financial year ending 31 December 2024. It was approved by the board on 28th March 2025.
