ENVIRONMENTAL AUTHORISATION - GAUT 002/24-25/E0003: ENVIRONMENTAL AND SOCIAL IMPACT ASSESSMENT (ESIA) FOR THE PROPOSED DEVELOPMENT OF A NEW MALTING PLANT SITED ON GRACEVIEW INDUSTRIAL PARK WITHIN THE MIDVAAL LOCAL MUNICIPALITY, IN SEDIBENG DISTRICT MUNICIPALITY, GAUTENG PROVINCE

The Gauteng Department of Agriculture, Rural Development and Environment (GDARDE) has granted a positive Environmental Authorisation to Soufflet Malt (Pty) Ltd in respect of the aforementioned project in terms of the National Environmental Management Act, 1998 (Act No. 107 of 1998) (as amended): GN R. 324 - 327. The EA was issued on 07 March 2025.

NOTICE OF ENVIRONMENTAL AUTHORISATION

In accordance with Regulation 4 (2) of the EIA Regulations 2014 (as amended), the applicant must in writing within fourteen (14) calendar days of the date of the EA notify all registered Interested and Affected Parties (I&APs) of the decision. NOTICE OF APPEAL PROCESS

In terms of Regulation 4(1) of the National Appeal Regulations, 2014 (GN R.993), an appellant must submit the appeal to the Appeal Administrator, and a copy of the appeal to the applicant, any registered Interested and Affected Party (I&AP) and any Organ of State with interest in the matter within 20 days from:

- a) The date that the notification of the decision for an application for an environmental authorisation was sent to the registered Interested and Affected Parties (I&APs) by the applicant (i.e. 18 March 2024).

An appeal submission must be accompanied by:

- i. A statement setting out the grounds of appeal;
- ii. Supporting documentation which is referred to in the appeal submission; and
- iii. A statement, including supporting documentation, by the appellant to confirm compliance with regulation 4(1) of the National Appeals Regulations, 2014 (GN R.993).
